2. Opening Remarks and Introductions

Ryan Patterson, Trust Chairperson and Stephanie Moore, Gallagher began the meeting by thanking everyone for coming. All Trustees and vendors introduced themselves.

3. Medical Claims Review

Krista Keller with AmeriBen reviewed the Trust's Medical claims experience from July 01, 2023 – June 30, 2024.

4. Medical Network Discount and Utilization Overview

Mike Groeger & Rachele Martin, BCBSAZ, provided an overview of discount savings, rate guarantees, and service enhancements for the period of December 01, 2023-November 30, 2024.

5. Prescription Drug Utilization Review

Bryan Espinoza and Lisa Thompson with Navitus discussed with Trustees how the Prescription Plan ran from January 01, 2024 – September 30, 2024 and rebates received.

6. Medical Management Overview

Jennifer Huppenthal, American Health Group, provided an update on Utilization Review and Case Management Services from January 01, 2024 – December 31, 2024

7. Dental & Vision Claims Overview

Lynn Harris with Ameritas reviewed the Dental and Vision Plan Utilization and also provided an overview adding the EyeMed Network and the Dental Fusion Plan from July 01, 2024 – December 31, 2024.

8. Aetna Voluntary Benefits Overview

Megan Stavros, Gallagher Voluntary Benefits Consultant, discussed the enrollment and utilization of the Accident, Critical Illness and Hospital Indemnity Plans from July 01, 2024 – December 31, 2024.

9. Basic Life/Additional Death & Dismemberment and Voluntary Term Life (VTL) Overview

Bill Ochs with Ochs Inc. provided an overview of the Employer Basic Life and Voluntary Term Life for the 2023-2024 Plan Year. Bill also discussed with Trustees a 3-year rate guarantee with no increase to current rates.

10. Recommended Claim Funding Rates for the 2025-2026 Plan Year

Michael Reich and Ryan Olson with Cheiron, explained to Trustees how the claim funding amounts were formulated for the upcoming Plan Year and what was driving the increase. Michael and Ryan presented Cheiron's recommended funding factors for the 2025-2026 Plan Year.

11. 2025-2026 Renewal Discussion & Benefit Building Trustee Budget Workshop/Discussion

Stephanie Moore and Amanda Weaver from Gallagher and Michael Reich and Ryan Olson from Cheiron reviewed rate impacts and the pricing of benefit options. Trustees discussed percentage increase and benefit change options to be decided upon at the Trust meeting scheduled for the following morning.
